# The rental companies demand to unify the regulation by means of a Mobility Law

The National Business Federation of Vehicle Rental with and without a driver (Feneval) has urged the Government to “urgently” develop a general mobility law so that Spain has a common regulation throughout the territory, focusing mainly on the search for more efficient and sustainable mobility, as well as in other aspects such as security or taxation.

In this matter, the organization proposes a new common registration tax throughout the country that is based on the same classification of environmental labels and not only on the carbon dioxide (CO2) emissions of each vehicle.

Likewise, it asks to reach the VAT equalization to the rest of the tourism sector for car rental services, the establishment of a Property Transfer Tax (ITP) by sections in accordance with the registration tax and tax advantages for individuals and companies in the purchase or use of low emission vehicles.

The president of Feneval, Juan Luis Barahona, has also requested the current Executive to have the ‘rent a car’ sector for the development of a new law that regulates “fairly” the changes that the mobility sector is experiencing, through “nationally consistent” regulations.

Eliminate regional differences

Barahona urges the elimination of differentiators by autonomy or municipality, since there is currently no common regulation between the different municipalities of Spain, which considers that it “limits” the possibilities of mobility of citizens within the national territory.

In addition to the fiscal area, the sector includes six other sections, such as ecology and environment, where it urges the development of public electric charging areas, although without discarding any type of energy source, considering that, given the technological advances, it has achieved for example comply with the “strict” regulations ‘Euro 6’.

In the technological and security and user protection areas, it proposes the telematic identification of vehicles throughout the national territory, eliminating the obligation to physically exhibit environmental labels, the development of legislation that allows autonomous vehicle testing spaces in specific areas and the harmonization of regulations for all agents that are dedicated to the rental of vehicles, such as insurance coverage, information collection, contracts, rights and obligations for the user.

In addition, it suggests offering bonuses or free parking for low-emission vehicles, harmonizing operation

in restricted traffic areas in different cities so that vehicles can also circulate throughout all areas, prioritize non-polluting vehicles, rental and transport public and specific regulations for vehicles without a license, such as bicycles or scooters.

However, remember that all these aspects must be compatible in structure, positions and deadlines with European regulations, since without it "it would be unfeasible" for the automotive industry and services to carry out their activity normally, harming the economy and the individuals with respect to other European countries. .

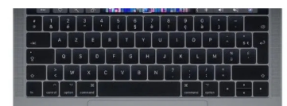
